



## DATA PROCESSING CLAUSE

### 1. The Controller of your personal data is:

### 2. Your personal data will be processed for the purpose of:

- proper and necessary performance of a contract / commercial services, including taking steps at the request of the data subject prior to entering into a contract / accepting an order - the data provided will be processed under article 6 section 1 letter b) and in accordance with the General Data Protection Regulation;
- the data provided will be processed under article 6 section 1 letter a) and in accordance with the General Data Protection Regulation;
- performance of actions required by the existing legal and administrative procedures
- the data provided will be processed under article 6 section 1 letter c) and in accordance with the General Data Protection Regulation;
- the legitimate interest pursued by Kando Plus Sp. z o.o. Sp. k. and, in particular: to pursue or secure claims against the clients, conduct analyses of quality of offered sales services - the data provided will be processed under article 6 section 1;
- sending commercial information on the services provided by the company by means of electronic communication within the meaning of the act of July 18, 2002 on Providing Services by Electronic Means (Journal of Laws of 2017, item 1219, consolidated text) to the specified e-mail address;
- in accordance with the General Data Protection Regulation;
- transfer your personal data to ING Bank Śląski S.A. ('Bank') in connection with:
- the service provided to the Internet Store by the Bank, i.e. provision of access to an online payment infrastructure (legal basis: article 6 section 1 letter f) of the Regulation,



- the processing and settlement of online payments made by the clients of the Internet Store using payment instruments by the Bank (legal basis: article 6 section 1 letter f) of the Regulation),
- verification of due performance of contracts concluded with the Internet Store by the Bank, in particular ensuring the protection of the payers' interests in connection with the complaints lodged by them (legal basis: article 6 section 1 letter f) of the Regulation).

**3.** In connection with the processing of personal data for the purposes specified in sec. 2, your personal data can be disclosed by the Internet Store to other recipients or categories of recipients of personal data which may include:

- ING Bank Śląski S.A.;
- Twisto Polska sp. z o.o.

**4. Your personal data was acquired in connection with the performance of a contract / commercial services and include:**

- first and last name;
- company names;
- contact details and e-mail address;
- information concerning the conducted economic activity.

**5. The recipient of your personal data shall be:**

- employees of Kando Plus Sp. z o.o. Sp. k. who are authorised to process personal data;
- entities that provide telecommunications, IT, organisational and technical services to Kando Plus Sp. z o.o. Sp. k.;
- institutions authorised to process personal data under the applicable law;
- your personal data specified in sec. 3 shall not be transferred to a third country/international organisation.

**6. Your personal data shall be processed until** you object to the processing thereof and, in the event of an objection, throughout the limitation period for claims the data subject may be entitled to.

**7. As the Controller of your personal data, we inform you** that you have the right of access to your personal data and the right of rectification. You also have the right to data erasure, data portability, restriction or cessation of the processing as well as the right to lodge a complaint to a supervisory authority – President of the Office of Personal Data Protection.

**8. The provision of personal data is voluntary,** but necessary for the purpose of steps referred to in sec. 2 of this data processing clause.

**9.** In the event that the personal data is provided by you for the purpose of entering into a contract with the Internet Store, the provision of personal data is the condition for entering into the said contract. In this situation, the provision of personal data is voluntary, but the consequence of failing to provide the personal data will be an inability to enter into a contract with the Internet Store.

In the event that the personal data is provided by you for the purpose of being transferred to Twisto Polska sp. z o.o. before entering a contract for the sale of goods (or services) purchased from the Internet Store, the provision of personal data is the condition for entering into the contract of sale in connection with the business model adopted by the Internet Store.

In the event that your personal data is transferred to the Bank in connection with the processing and settlement of online payments made by you to the Internet Store using payment instruments, the provision of personal data is required for the execution of the payment and delivery of a payment confirmation to the Internet Store by the Bank.

In the event that your personal data is transferred to the Bank for the purpose of verification of due performance of contracts concluded with the Internet Store, in particular ensuring the protection of the payers' interests in connection with the complaints lodged by them, the provision of personal data is required in order to enable the performance of the contract concluded between the Internet Store and the Bank.

In the event that your personal data is transferred to Twisto Polska sp. z o.o. in connection with the option to make a payment for the purchased goods or services through Twisto Polska sp. z o.o. under the contract of mandate covering the 'Kup z Twisto (Buy with Twisto)' shopping formula and the provision of the said formula by the Internet Store, the provision and processing of personal data is required in connection with the business model adopted by the Internet Store and the performance of the contract concluded between the Internet Store and Twisto Polska Sp. z o.o.

*The aforementioned clause fulfils the legal obligation stemming from the Regulation (EU) 2016/679 of the European Parliament and of the Council of April 27, 2016 on the protection of natural persons with regard to the processing of personal data and on the free movement of such data, and repealing Directive 95/46/EC.*

*It does not require you to take any action.*
